





- Protect from freezing, remove filter cartridge when temperatures are expected to drop below 40°F (4.4°C).
- Do not install on hot water supply lines. The maximum operating water temperature of this filter system is 100°F (37.8°C).
- Do not install if water pressure exceeds 100 psi (689 kPa). If your water pressure
 exceeds 80 psi (552 kPa), you must install a pressure limiting valve. Contact a plumbing
 professional if you are uncertain how to check your water pressure.
- Do not install where water hammer conditions may occur. If water hammer conditions exist you must install a water hammer arrester. Contact a plumbing professional if you are uncertain how to check for this condition.
- The disposable filter cartridge MUST be replaced every 12 months, at the rated capacity
 or if a noticeable reduction in flow rate occurs.

The disposable filter cartridge is warranted from defects in material and workmanship for a period of one (1) year from the date of purchase. If the Product is defective CUNO will replace the Product or refund your Product purchase price.
